It is considered necessary to make the above Speed Limit Order to introduce a 20mph speed limit for avoiding danger to persons or other traffic using Braemore Wood, Troon including pedestrians, so keeping vehicles to a speed suitable for the nature of the road and adjacent properties.

South Ayrshire Council in exercise of the powers conferred on it by Section, 84 of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

PART I GENERAL

Citation and commencement

1. This Order may be cited as "South Ayrshire Council (Braemore Wood, Troon) (20mph Speed Limit) Order 20__" and shall come into force on ______ 20__

Interpretation

2. In this Order the following expressions have the meanings hereby assigned to them—

"Council" means South Ayrshire Council, constituted under the Local Government etc. (Scotland) Act 1994 and having its principal office at County Buildings, Wellington Square, Ayr KA7 1DR;

"the 1984 Act" means the Road Traffic Regulation Act 1984;

"motor vehicle" unless the context otherwise requires, means a motor vehicle to include a mechanically propelled intended or adapted for use on the road;

"Schedule" means the Schedule annexed and signed as relative hereto;

3. A reference in this Order to

- (a) any enactment or order is a reference to that enactment or order as amended by any subsequent enactment or order;
- (b) a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order; and
- (c) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament.

PART II SPEED LIMIT

Twenty Miles Per Hour Limit Speed Limit

- 4. Save as provided in Article 5 it shall not be lawful for any person to drive a motor vehicle at a speed exceeding 20mph on the lengths of the roads specified in Schedule 1.
- 5. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

20MPH SPEED LIMIT

Length of Road in the Area of South Ayrshire within the Town of Troon

		Plan No.
1. Braemore Wood	From its junction with Wilson Avenue southwestwards and north-westwards for a distance of 251 metres.	1
2. Braemore Wood central spur	That length of road running from a point between Nos.17 and 31, south-westwards for a distance of 72 metres.	1
3. Braemore Wood western spur	From a point outside of Nos. 18/20 southwestwards for its entire length, a distance of 194 metres.	1
