South Ayrshire Council, in exercise of the powers conferred on it by Sections 1(1), 2(1) and (2), 99, 101, and 102, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended, the Road Traffic (Permitted Parking Area and Special Parking Area) (South Ayrshire Council) Designation Order 2012 and the Road Traffic Act 1991 and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

PART I  
GENERAL

*Citation and commencement*

1. This Order may be cited as the "South Ayrshire Council (Town of Prestwick) (Waiting Restrictions) (Civil Enforcement) Order 2012 Amendment Order No.1 201\_", and shall come into force on .

*Interpretation*

2. In this Order the following expressions have the meanings hereby assigned to them:

“Council” means South Ayrshire Council;

“Schedule” means the SCHEDULE(S) annexed and signed as relative hereto;

3. A reference in this Order to

- (a) any enactment or Order is a reference to that enactment or Order as amended by any subsequent enactment or Order;
- (b) a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order; and
- (c) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament.

PART II
